LCS employees shall support, espouse, and in all respects give allegiance to the following statement of faith:

- We believe the Bible to be the inspired Word of God without error.
- We believe in one God, Creator of all things. We believe in the Trinity: Father, Son & Holy Spirit as three in one
- We believe Jesus Christ is true God and man, born of the Virgin Mary. He died on the cross as payment for our sins. He arose on the third day, ascended into heaven and will return some day for us.
- We believe the ministry of the Holy Spirit is to indwell, guide, instruct and empower believers for godly living and service.
- We believe Satan is a fallen angel, and enemy of God and man who has been defeated through the death and resurrection of Jesus Christ.
- We believe that all have sinned and fallen short of the glory of God, but the shed blood of Jesus Christ provides salvation and redemption for all who believe.



- We believe the Church is composed of all individuals who have been saved through faith in Jesus and that He is the Head of the Church.
